## Rationale

All new and revised National Courses reflect the Curriculum for Excellence values, purposes and principles. They offer flexibility, provide more time for learning, more focus on skills and applying learning, and scope for personalisation and choice.

In this Course, and its component Units, there will be an emphasis on skills development and the application of those skills. Assessment approaches will be proportionate, fit for purpose and will promote best practice, enabling learners to achieve the highest standards they can.

This Course provides learners with opportunities to continue to acquire and develop the attributes and capabilities of the four capacities, as well as skills for learning, skills for life and skills for work.

All Courses provide opportunities for learners to develop breadth, challenge and application, but the focus and balance of the assessment will be appropriate for the subject area.

# Relationship between the Course and Curriculum for Excellence values, purposes and principles

The Course is practical and experiential and the key focus is creativity. Learning in the Course will develop knowledge of art and design practice and a range of practical media handling skills in both expressive and design contexts.

The Course encourages learners to exercise imagination and creativity. It helps learners to be creative and to express themselves confidently in different ways. Learning in the Course will include active involvement in creative activities and the use of a range of art and design materials, techniques and/or technology. Learning through art and design also develops learners' ability to critically appreciate aesthetic and cultural values, identities and ideas.

The Course allows learners to broaden and deepen their skills base, to widen their horizons regarding a range of vocations and careers and to develop attributes and capabilities of the four capacities. Throughout the Course learners will develop creativity, perseverance, independence and resilience.

# Purpose and aims of the Course

The purpose of the Course is to provide a broad practical experience of art and design and related critical activity. The Course provides opportunities for learners to be inspired and creatively challenged as they explore how to visually represent and communicate their personal thoughts, ideas and feelings through their work.

Learners will investigate the factors influencing artists and designers work and practice and will use this understanding when developing and producing their creative expressive art and design work.

The skills that learners gain by successfully completing the Course will be valuable for learning, life and work. Learners will investigate and analyse how artists and designers have used materials, techniques and/or technology in their work, before experimenting with and using these when developing their ideas. They will develop creativity and problem solving skills when experimenting with and using materials, techniques and/or technology in creative ways. Critical thinking and reflective skills will also be developed as learners review and refine their work.

The aims of the Course are to enable learners to:

- communicate personal thoughts, feelings and ideas through the creative use of art and design materials, techniques and/or technology
- develop critical understanding of a range of art and design practice
- plan, develop, produce and present creative art and design work
- understand the impact of external factors on artists and designers and their work
- develop creativity, problem solving, critical thinking and reflective practice skills

## Information about typical learners who might do the Course

This Course is a broad-based qualification. It is suitable for all learners with an interest in art and design, and for those wanting to progress onto higher levels of study. This qualification will allow learners to consolidate and extend their art and design skills.

The Course is learner-centred and includes practical and experiential learning opportunities. The learning experiences in the Course are flexible and adaptable, with opportunities for personalisation and choice in both expressive and design contexts. This makes it highly accessible, as it can be contextualised to suit a diverse range of learners' needs and aspirations.

On completing the Course, learners will have developed skills in planning, producing and presenting creative art and design work. They will be able to use art and design materials, techniques and/or technology in creative ways when developing and refining their ideas and work. Learners will also have developed understanding of artists and designers as creative practitioners.

# Course structure and conditions of award

#### Course structure

The Course has an integrated approach to learning, and includes a mix of practical learning and knowledge and understanding of art and design practice.

In the Course learners will draw upon their understanding of the main factors influencing artists' and designers' work and practice. They will experiment with and use a range of art and design materials, techniques and/or technology to develop their own creative art and design work. Learners will use problem solving skills and self-reflect on their creative choices and decisions when developing their creative ideas.

Units are statements of standards for assessment and not programmes of learning and teaching. They can be delivered in a number of ways.

The Course consists of two mandatory Units and the Course assessment.

Both Units are designed to provide progression to the corresponding Units at Higher.

#### **Art and Design: Expressive Activity (National 5)**

This Unit helps learners to develop their personal thoughts and ideas in visual form. In the Unit, learners will develop critical understanding of artists' working practices and the social and cultural influences affecting their work. They will select stimuli and produce analytical drawings and studies. They will develop and refine their expressive ideas and artwork, experimenting with and using a range of materials, techniques and/or technology in 2D and/or 3D formats when responding to stimuli.

#### Art and Design: Design Activity (National 5)

In this Unit learners will plan, research and develop creative design work in response to a design brief. They will develop their creativity, problem solving and critical thinking skills as they consider design opportunities, and work to resolve design issues and constraints. In the Unit, learners will develop critical understanding of designers' working practices and the main social and cultural influences affecting their work. They will experiment with, develop and refine their design ideas, using a range of materials, techniques and/or technology in 2D and/or 3D formats.

#### Conditions of award

To gain the award of the Course, the learner must pass all of the Units as well as the Course assessment. The required Units are shown in the Course outline section. Course assessment will provide the basis for grading attainment in the Course award.

# Skills, knowledge and understanding

Further information on the assessment of the skills, knowledge and understanding for the Course is given in the *Course Assessment Specification*. A broad overview of the mandatory subject skills, knowledge and understanding that will be assessed in the Course is given in this section. These are:

- producing analytical drawings and related investigative studies in response to stimuli
- using visual elements expressively, showing a clear understanding of the subject matter
- producing focused investigative visual and market research for a design activity
- skills in using a range of art and design materials, techniques and/or technology creatively
- developing and refining a variety of creative ideas for art and design work in 2D and/or 3D formats
- describing how artists and designers use materials, techniques and/or technology in their work
- analysing the impact of social, cultural and other influences on artists' and designers' work and practice
- using problem solving, planning and self-evaluation skills within the creative process

Skills, knowledge and understanding to be included in the Course will be appropriate to the SCQF level of the Course. The SCQF level descriptors give further information on characteristics and expected performance at each SCQF level (<a href="www.sqa.org.uk/scqf">www.sqa.org.uk/scqf</a>).

# **Assessment**

#### Unit assessment

All Units are internally assessed against the requirements shown in the Unit Specification.

They can be assessed on an individual Unit basis or by using other approaches which combine the assessment for more than one Unit.

They will be assessed on a pass/fail basis within centres. SQA will provide rigorous external quality assurance, including external verification, to ensure assessment judgements are consistent and meet national standards.

The assessment of the Units in this Course will be as follows.

#### **Art and Design: Expressive Activity (National 5)**

In this Unit, evidence will be required to show that the learner can produce a range of creative ideas and art work in response to stimuli. Learners will produce analytical drawings, investigative studies and expressive development work showing visual continuity and progressive development of their ideas. Knowledge and understanding of expressive artists and art practice will also be assessed.

#### Art and Design: Design Activity (National 5)

In this Unit, evidence will be required to show that the learner can produce a range of creative ideas in response to a design brief. Learners will produce investigative studies and market research. They will experiment with and use materials, techniques and/or technology when developing and refining their design ideas. Knowledge and understanding of designers and design practice will also be assessed.

#### Course assessment

Courses from National 4 to Advanced Higher include assessment of <u>added value</u><sup>1</sup>. At National 5, Higher and Advanced Higher, the added value will be assessed in the Course assessment. The added value for the Course must address the key purposes and aims of the Course as defined in the Course Rationale. It will do this by addressing one or more of breadth, challenge and application.

In the National 5 Art and Design Course, added value will focus on:

- challenge
- ♦ application

The learner will draw on, extend and apply the skills they have learned during the Course. This will be assessed through a <u>portfolio</u> and a <u>question paper</u><sup>2</sup>.

In the portfolio, learners will produce one piece of expressive art work and one design solution. The portfolio will be sufficiently open and flexible to allow for personalisation and choice and will focus on both the process and products of learning.

The question paper adds value by requiring integration and application of knowledge and skills from across the Units.
