#### General marking principles for Advanced Higher Graphic Communication

Always apply these general principles. Use them in conjunction with the specific marking instructions, which identify the key features required in candidates' responses.

- (a) Always use positive marking. This means candidates accumulate marks for the demonstration of relevant skills, knowledge and understanding; marks are not deducted for errors or omissions.
- (b) If a candidate response does not seem to be covered by either the principles or detailed marking instructions, and you are uncertain how to assess it, you must seek guidance from your team leader.
- (c) For 'Describe' questions

Candidates must provide a statement or structure of characteristics and/or features, not just an outline or a list. For example they can refer to a concept, experiment, situation or facts in the context of and appropriate to the question. The number of marks available for a question indicates the number of factual/appropriate points required.

(d) For 'Explain' questions

Candidates must relate cause and effect and/or define relationships. This must be in the context of the question, or a specific area within the question.

(e) For 'Compare' questions

Candidates must demonstrate knowledge and understanding of the similarities and/or differences between things, methods, or choices. This must be in the context of the question, or a specific area within the question.

(f) Candidates can respond to any question using text, sketching, annotations or combinations of these. Award marks for the information conveyed. Do not award marks for the quality of sketching.

Accept: photograph must be high/high enough resolution.

(a)	<ul> <li>STL files are the standard in 3D printing which ensures the 3D printer can easily read the data specific to the model.</li> <li>STL files splice the model into several printable layers for accurate printing.</li> <li>STL files can enable identification of weak points in the print, so structural meshes can be added to strengthen the model.</li> <li>STL files will provide all of the required details for volume, mass surface geometry etc. to ensure the model can be printed accurately.</li> <li>Retains only the essential 3D geometric data required by the printer</li> </ul>	2	
	(b)	<ul> <li>Volume:</li> <li>Volume data ensures the model being printed fits in volume inside the 3D printer.</li> <li>Volume data can be used to check if there is sufficient print filament available.</li> <li>Centre of Mass:</li> <li>Areas of greater mass can be supported to prevent collapse*</li> <li>Can be used to determine centre of gravity/where the model is unstable so it can be supported during printing.</li> <li>Determines the distribution of mass within a model indicating the areas of greater rigidity or strength, including supporting its own weight.</li> <li>Model Mass:</li> <li>Can provide details on the quantity of material required for the build, which can help with costings and reducing material waste.</li> </ul>	3	* Accept for 'centre of mass' or 'model mass' Data will determine where supports strengthening creating mesh supports are needed

<b>2.</b> (c)		<ul> <li>Volumetrics:</li> <li>Create a realistic representation of the water within the swimming pool.</li> <li>This shows the clarity in the water/depth of the pool/realistic distortion of the tile pattern</li> <li>Shows the dissipation/distortion of light in the water</li> <li>Gives the impression of mist/fog/haziness in the distance (before the last line of trees)</li> <li>Bump Mapping:</li> <li>Used in the woodwork features to enhance the definition of the grain texture found within this material.</li> <li>Used in the rocks to show the rough texture found within this material.</li> <li>Used in the furniture fabric to show they are soft furnishings.</li> <li>Used within the tiles features to enhance the definition of the texture found within this material.</li> <li>Used in the black marble/highly reflective material around the pool to show it is smooth.</li> <li>Used within the grass/leaves to add depth/definition to the texture of the foliage.</li> <li>IBL:</li> <li>Realistic scene capturing the lighting of the environment or the effects of light on the environment.</li> <li>Reflections captured in the water of the surrounding environment.</li> <li>Reflections captured in the windows from the surrounding area/sited environment.</li> </ul>	6	2 marks for each area. (g)		<ul> <li>Advantage of MOV. files</li> <li>Can store both audio and video elements (of separate files).</li> <li>Excellent for web based applications.</li> <li>Can be embedded within other programs such as apps etc.</li> <li>Is easily edited without having to rewrite code.</li> <li>Provides high quality playback.</li> <li>Disadvantages of MOV. files</li> <li>Often requires QuickTime player to run/is not compatible across all software platforms.</li> <li>Compression can result in diminished quality in some cases.</li> <li>Large file sizes (due to high quality playback).</li> </ul>	2	Accept: For advantages: file can be compressed to aid data transfer (however note disadvantages).

4. (a)	<ul> <li>Colour space</li> <li>The graphic designer would be using an RGB monitor so the colour space would be different to the CMYK file that they would be working on. They would have to careful to colour match them before printing</li> <li>A specific CYMK colour would be used to get the correct print colours</li> <li>The designer could use Pantone colours (PMS) to clarify colour choice/colour representation between digital and print.</li> <li>Bleed area</li> <li>A bleed area would be set for any run over (items designed to go beyond the cropped edge of the book sleeve)</li> <li>Bleed area must be large enough to ensure bleed but not so large as to waste ink</li> <li>Bleed will need to be carefully checked along with paper choice and crop mark positions to avoid print error</li> <li>The choice of the bleed area will not be clear during designing so print preview/test print/camera ready copy will all be used to confirm settings</li> <li>Dots per inch</li> <li>DPI will need to be a minimum of 300 dpi to ensure required print quality.</li> <li>There will need to be similarity between the PPI and the DPI so the screen design matches the print design if any quality assurance is to be done onscreen.</li> <li>PPI can be very high on a PC and in DTP software but DPI will dictate the final quality.</li> </ul>	3	Accept: Bleed Area • Ensures edge to edge print. • No white border around finished item DPI • The higher the DPI the larger the file size • The higher the DPI the higher the cost and possibly the print time. Dots per Inch (DPI): Candidates do not need to mention 300dpi just that the higher the resolution the higher the image quality.

Candidates must explain the choice of printing technique based on the specification.
	(c)		<ul> <li>The image will not be the required resolution if printed from a screen-shot</li> <li>The print will not look the same on the smooth calendared paper</li> <li>The ink jet printer will not reproduce the colours the same as the offset lithography machine</li> </ul>	3	Do not accept a rewording of the question. (a)		<ul> <li>Motion capture</li> <li>This is an accurate way to represent human movement as data can be capture from the real thing.</li> <li>The animation will be more believable/better to watch/more realistic as it will match the walking and arm movements of the human body accurately.</li> <li>The animator can request all required body movements and record this data.</li> <li>There will no movements that are unnatural.</li> <li>Motion tweening</li> <li>Simple form of animation to create an action sequence</li> <li>Used to position of the character and limb positions at key points in the action sequence (software filling in in-between frames)</li> <li>Allows for adjustment the frame rate/resolution to change the output</li> <li>Can be edited to improve the realism/smoothness of the movements</li> <li>Can be edited to add more actions into the sequence</li> <li>Allows the designer/animator to control of the number of key frames required output.</li> </ul>	4	Maximum of 3 marks for each animation technique.

(d)	<ul> <li>Transitions</li> <li>Transitions would be used to add interest/breaks at different points in the animation eg to move between the close up of screen shot 2 and the more distant. screen shot 3, or when moving to different camera view points.</li> <li>Allows changes between scenes to be seamless.</li> </ul>	3	
		<ul> <li>Overlays</li> <li>Overlays could be used to add more information to the animation eg speech bubbles of what the character is saying, indicators of how well the game is going eg numbers of task complete etc</li> <li>Frame rates</li> <li>By changing the frame rate the speed of the character could be altered or the quality of the game play could be increased/decreased.</li> </ul>

		(ii)	<ul> <li>Quantity surveyor</li> <li>Quantity surveyor could work out the amount of tarmac, asphalt and paving required for the roads/pavements using the scale and requirements provided.</li> <li>Once the amount is worked out the quantity surveyor could provide costings.</li> <li>For the play area the quantity surveyor could work out the amount of solid rubber required and how many children's play items/fixtures and fittings etc. would be required. (c)		<ul> <li>Additional Layers</li> <li>Layer showing eg the colour of the houses on the locational plan to clearly indicate the types of house</li> <li>Layers showing additional features within the location plan eg street lighting, traffic calming measures, pedestrian crossings etc.that provides further information on safety/accessibility</li> <li>Layer showing a simple linear scale to make it easier to calculate distances/plot sizes.</li> </ul>	4	<ul> <li>1 mark for identifying a possible layer.</li> <li>1 mark for a suitable explanation.</li> <li>Accept: any layer in addition to existing content that is of clear relevance to a potential house buyer.</li> </ul>
