H5SS 04 (SCDHSC0369) — Support Individuals with Specific Communication Needs

Overview

This standard identifies the requirements when you support individuals who have specific communication needs. This includes identifying individuals' specific communication preferences and needs, supporting individuals to interact with other people and monitoring communication to identify changing needs.

Additional Information

Scope/range related to Performance Criteria

NOTE: Where an individual finds it difficult or impossible to express their own preferences and make decisions about their life, achievement of this standard may require the involvement of advocates or others who are able to represent the views and best interests of the individual.

Where there are language differences within the work setting, achievement of this standard may require the involvement of interpreters or translation services.

Barriers to communication may include those relating to the physical environment; to interpersonal relationships and the emotional environment; to working practices; to the availability of resources including human or other aids or assistance; to the limitations of your own or other people's communication skills or attentiveness; to cultural contexts; to the specific circumstances of the individual including disability, disadvantage, anxiety or distress.

To **communicate** may include using the individual's preferred spoken language, the use of signs, the use of symbols or pictures, writing, objects of reference, communication passports, other non-verbal forms of communication, human and technological aids to communication.

Communication cues may be those that are widely used and recognised by people; or specific to particular group(s); or specific to the individual.

Human aids to communication may include people who sign; people who take notes; people who `mouth'; people who speed type.

The **individual** is the adult, child or young person you support or care for in your work.

Key people are those who are important to an individual and who can make a difference to his or her wellbeing. Key people may include family, friends, carers and others with whom the individual has a supportive relationship.

Listening may encompass other ways of attending to and receiving what individuals communicate when using methods such as signing, objects of reference, touch, gesture, visual messages or technologies.

Others are your colleagues and other professionals whose work contributes to the individual's wellbeing and who enable you to carry out your role.

Scope/range related to Knowledge and Understanding

The details in this field are explanatory statements of scope and/or examples of possible contexts in which the NOS may apply; they are not to be regarded as range statements required for achievement of the NOS.

All knowledge statements must be applied in the context of this standard.

Factors that may affect the health, wellbeing and development of individuals may include: adverse circumstances or trauma before or during birth; autistic spectrum conditions; dementia; family circumstances; frailty; harm or abuse; injury; learning disability; medical conditions (chronic or acute); mental health; physical disability; physical ill health; poverty; profound or complex needs; sensory needs; social deprivation; substance misuse.

Values

Adherence to codes of practice or conduct where applicable to your role and the principles and values that underpin your work setting, including the rights of children, young people and adults. These include the rights:

- to be treated as an individual
- to be treated equally and not be discriminated against
- to be respected
- to have privacy
- ♦ to be treated in a dignified way
- to be protected from danger and harm
- to be supported and cared for in a way that meets their needs, takes account of their choices and also protects them
- to communicate using their preferred methods of communication and language
- to access information about themselves.

Support individuals to interact through communication

9	Support the individual to express their wishes about who they wish to communicate with and the ways in which they wish to communicate.	
10	Support the individual to overcome barriers they experience when communicating with others.	
11	Support the individual to develop communication methods and skills that will enable them to be understood by others.	
12	Support the individual to acquire any specific equipment to enable them to communicate.	
13	Support the individual to correctly set up and use communication equipment.	
14	Check that the equipment is working properly, taking appropriate actions to remedy any problems.	
15	Access other specialist services and facilities, including human aids to communication , to enable the individual to communicate.	
16	Provide opportunities for individuals to communicate with others using the communication methods and skills they have developed.	
17	Ensure the environment is arranged to minimise barriers to communication.	
18	Encourage the individual to engage with others.	
19	Encourage the individual to communicate their feelings and emotions in ways that will help you and other people to understand them.	
20	Support other people who come into contact with the individual to communicate with them appropriately.	

Support individuals to interact through communication (cont)

21	Support people to understand and respect the individual's specific communication needs, to understand and interpret the individual's communications and to use appropriate strategies and methods to be understood by the individual.	
22	Encourage people to allow sufficient time for the individual to communicate their message, without interrupting.	
23	Work with the individual to enable them to communicate in new and changing situations and environments.	

Monitor individuals' communication needs

24	Examine records and reports to enable you to observe appropriately and recognise changes in the individual's communication needs.	
25	Observe the individual while they are communicating with you, with key people and with others.	
26	Work with the individual and key people to monitor any changes in the individual's communication.	
27	Evaluate the changes observed.	
28	Seek further help, advice and support when your evaluation suggests that the individual's communication needs have changed.	
29	Complete records and reports about changes to the communication needs of the individual according to legal and work setting requirements.
