# **Unit Specification**

## Cleaning equipment

**URN: SDS 0436** 

SCQF Level: 5 | SCQF Credit:4

#### **Goal of Unit:**

To clean equipment to maintain health and safety standards in line with organisational procedures.

#### **Brief outline:**

This is about carrying out cleaning of equipment to meet organisational procedures following relevant manufacturers' instructions. This involves regular inspection of cleanliness of equipment, completing records and reporting faults to ensure equipment is clean, safe and fit for purpose.

#### **Performance requirements**

- 1. Checking schedules to identify equipment to be cleaned in line with organisational policies and procedures
- 2. Carrying out regular inspections of equipment to identify cleaning requirements in line with organisational policies and procedures
- 3. Preparing equipment for cleaning in line with manufacturers' instructions and organisational policies and procedures
- 4. Selecting correct cleaning tools and materials for equipment being cleaned in line with organisational policies and procedures
- 5. Using selected tools and materials to carry out cleaning of equipment in line with manufacturers' instructions and organisational policies and procedures
- Checking equipment operates after cleaning in line with manufacturers' instructions and organisational policies and procedures
- 7. Completing records for equipment cleaning accurately in line with organisational policies and procedures
- 8. Identifying and reporting equipment maintenance requirements in line with organisational policies and procedures
- 9. Handling and disposing of waste in line with relevant legislative requirements and organisational procedures

### Knowledge and understanding requirements

- 1. Health, safety, security and environmental regulations and organisational procedures and how to safely comply with them
- 2. Relevant regulations regarding preparation and use of equipment and when you need to complete required training and hold certificates
