



# Practical Electronics: Circuit Construction (National 4)

# Unit outline

The general aim of this Unit is to develop skills in assembling a range of electronic circuits, using permanent and non-permanent methods, to construct complete working devices. Learners will also develop skills in testing and fault-finding.

Learners who complete this Unit will be able to:

- 1 Plan the construction of electronic circuits
- 2 Construct working electronic circuits
- 3 Test electronic circuits

This Unit is a mandatory Unit of the Practical Electronics (National 4) Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provides advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

The Added Value Unit Specification for the Practical Electronics (National 4) Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Practical Electronics (National 4) Course.

## **Outcomes and assessment standards**

## Outcome 1

The learner will:

#### 1 Plan the construction of electronic circuits by:

- 1.1 Listing and sourcing the required components
- 1.2 Interpreting a layout diagram

## Outcome 2

The learner will:

#### 2 Construct working electronic circuits by:

- 2.1 Inserting components on to prototype board to a given layout
- 2.2 Soldering components on to stripboard or pre-printed PCB to a given layout
- 2.3 Applying a range of wiring techniques
- 2.4 Applying safe working practices

## Outcome 3

The learner will:

#### 3 Test electronic circuits by:

- 3.1 Following a testing checklist
- 3.2 Using continuity testers to check if circuits are open or closed
- 3.3 Using multimeters to measure resistance, current and voltage

For this Unit, typical circuits should involve a power supply, marking out of stripboard, placement and soldering of components, cutting track and wiring techniques between boards, where required.

## **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

For this Unit, learners will be required to demonstrate the ability to plan, construct and test electronic circuits, applying safe working practices. Evidence may be observational, obtained while the learner is carrying out appropriate practical tasks.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

## Assessment standard thresholds

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

• 7 out of 9 Assessment Standards must be achieved.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
